

Growth of a \$1,000 Investment





Performance results are total return and include the reinvestment of all income. For the periods prior to March 31, 2011, net of fee performance reflects the reduction of the highest WRAP fee charged (3.00% annually) and gross of fee performance has been reduced by transaction costs. For all other periods, net of fee performance reflects the deduction of actual wrap fees charged and gross of fee performance has not been reduced by transaction costs.
