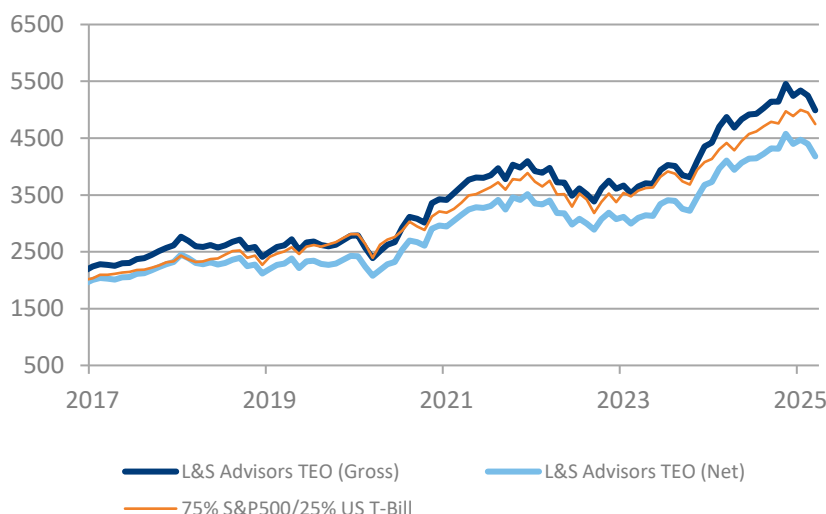
Investment Universe

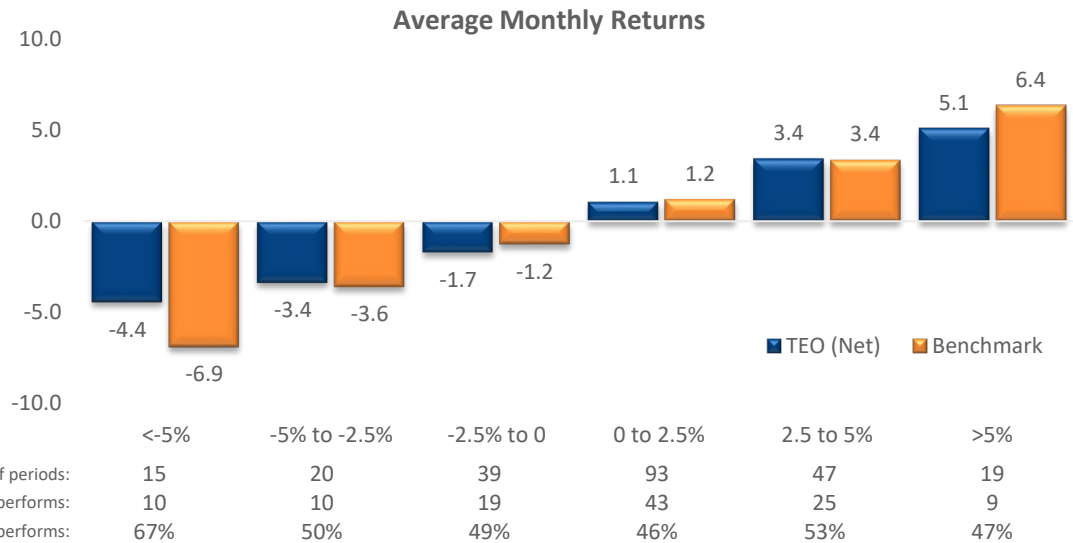

Strategy Philosophy

Our philosophy is based on two guiding principles: (1) we believe risk management transcends everything and (2) risk management occurs by investing around shifting probabilities. By listening to what the market is telling us, we make industry, sector, and portfolio wide allocation decisions, seeking to generate attractive returns with below-market risk over a full market cycle.

These core investment principles have been the focus of the strategy since inception. We believe in order to realize the full benefits of the strategy, the primary performance objective of generating attractive risk adjusted returns is achieved over a full market cycle (5-7 years).

L&S performance results prior to the reformation of the firm were achieved by the portfolio managers at a prior entity and have been linked to the performance history of L&S Advisors. The firm is defined as all accounts exclusively managed by L&S from 10/31/2005, as well as accounts managed in conjunction with other, external advisors via the Wells Fargo DMA investment program for the periods 05/02/2014, through the present time.
